**Schedule "A":**

Each person or entity classified as Schedule A shall pay a license in an amount based on gross annual receipts for the calendar year immediately preceding the current license year as follows:

1. On gross receipts less than \$35,000, license fee of \$50.00.
2. On gross receipts of \$35,000 but less than \$95,000, license fee of \$100.00.
3. On gross receipts of \$95,000 but less than \$125,000, license fee of \$125.00.
4. On gross receipts of \$125,000 but less than \$175,000, license fee of \$150.00.
5. On gross receipts of \$175,000 but less than \$225,000, license fee of \$175.00.
6. On gross receipts of \$225,000 but less than \$300,000, license fee of \$200.00.
7. On gross receipts of \$300,000 but less than \$375,000, license fee of \$225.00.
8. On gross receipts of \$375,000 but less than \$425,000, license fee of \$250.00.
9. On gross receipts of \$425,000 but less than \$525,000, license fee of \$275.00.
10. On gross receipts of \$525,000 but less than \$700,000, license fee of \$300.00.
11. On gross receipts of \$700,000 but less than \$1,000,000, license fee of \$325.00.
12. On gross receipts of \$1,000,000 and over, license fee of \$375.00.

### Schedule "B":

Each person or entity classified as Schedule B shall pay a license in an amount based on gross annual receipts for the calendar year immediately preceding the current license year as follows:

1. The license shall be \$50.00 plus a sum of money equal to fifty cents (\$0.50) per one thousand dollars (\$1,000.00) of gross annual receipts for the year preceding the current license year.

### Schedule "C":

Each person or entity classified as Schedule C shall pay a license in an amount based on gross annual receipts for the calendar year immediately preceding the current license year as follows:

1. On gross receipts of not more than one hundred thousand dollars (\$100,000.00) the license will be one hundred dollars (\$100.00).
2. On gross receipts of more than one hundred thousand dollars (\$100,000.00) but not more than five hundred thousand dollars (\$500,000.00) the license shall be two hundred dollars (\$200.00).
3. On gross receipts of more than five hundred thousand dollars (\$500,000.00) but not more than one million dollars (\$1,000,000.00) the license shall be three hundred dollars (\$300.00).
4. On gross receipts of more than one million dollars (\$1,000,000.00) but not more than three million dollars (\$3,000,000.00) the license shall be five hundred dollars (\$500.00)
5. On gross receipts of more than three million dollars (\$3,000,000.00) but not more than five million dollars (\$5,000,000.00) the license shall be one thousand dollars (\$750.00).
6. On gross receipts of more than five million dollars (\$5,000,000.00) the license shall be one thousand dollars (\$1,000.00).

### Schedule "D" :

Each person or entity classified as Schedule D shall pay a license in an amount based on gross annual receipts for the calendar year immediately preceding the current license year as follows:

1. On gross receipts of less than fifteen thousand dollars (\$15,000.00) the license shall be fifty dollars (\$50.00).
2. On gross receipts of fifteen thousand dollars (\$15,000.00) to seventy thousand dollars (\$70,000.00) the license shall be one seventy five dollars (\$75.00).

On gross receipts of over seventy thousand dollars (\$70,000.00) the license shall be one hundred dollars (\$100.00) plus fifty cents (\$0.50) per thousand dollars of gross receipts over seventy thousand dollars (\$70,000.00).

### Schedule "E" :

Each person or entity classified as Schedule E shall pay a license in an amount based on gross annual receipts for the calendar year immediately preceding the current license year as follows:

1. On gross receipts up to fifty thousand dollars (\$50,000.00) the license shall be fifty dollars (\$50.00).
2. On gross receipts of fifty thousand dollars (\$50,000.00) but less than one hundred fifty thousand dollars (\$150,000.00) the license shall be seventy-five dollars (\$75.00).
3. On gross receipts of one hundred fifty thousand dollars (\$150,000.00) but less than two hundred fifty thousand dollars (\$250,000.00) the license shall be one hundred dollars (\$100.00).
4. On gross receipts of over two hundred fifty thousand dollars (\$250,000.00) but less than five hundred thousand (\$500,000) the license shall be one hundred fifty dollars (\$150.00).
5. On gross receipts of over five hundred thousand (\$500,000) the license shall be three hundred dollars (\$300.00).

**Schedule "K" - Special Events Licenses**

**Schedule "L" - Fortune Tellers**

Yearly rate is \$2,000.

This type of license must be presented to the Mayor and Council at a regular scheduled Council Meeting of the City of Jackson and voted on at the next regular scheduled Council Meeting of the City of Jackson, Alabama.

**Schedule "M" - Vending Machines**

In addition to the license thereto, there shall be a decal affixed to each machine and the cost of said decals shall be according to the following table:

1 to 5 machines vending any type merchandise or product	\$ 20.00 per decal
5 to 10 machines vending any type merchandise or product	\$ 10.00 per decal
all over 10 machines vending any type merchandise or product	\$ 5.00 per decal

**Schedule "N" - Billiard and/or Pool Tables**

### Schedule "S" - Delivery License

The rate for the delivery license is established in Section 21 and is: \$ 50.00

#### SECTION 21. Delivery License.

- (a) In lieu of any other type of license, a taxpayer may at its option purchase for \$ 50.00 plus the issuance fee, a delivery license for the privilege of delivering its merchandise in the municipality if the taxpayer meets all of the following criteria:
- (1) Other than deliveries, the taxpayer has no other physical presence within the municipality or its police jurisdiction;
  - (2) The taxpayer conducts no other business in the municipality other than delivering merchandise and performing the requisite set-up and installation of said merchandise;
  - (3) Such delivery and set-up and installation is performed by the taxpayer's employees or agents, concerns the taxpayer's own merchandise in that municipality, and is done by means of delivery vehicles owned, leased, or contracted by the taxpayer;
  - (4) The gross receipts derived from the sale and any requisite set-up or installation of all merchandise so delivered shall not exceed seventy-five thousand dollars (\$75,000) during the license year;
  - (5) Any set-up or installation shall relate only to (i) that required by the contract between the taxpayer and the customer or as may be required by state or local law, and (ii) the merchandise so delivered;
  - (6) If at any time during the current license year the taxpayer fails to meet any of the above stated criteria, then within 10 days after any of said criteria have been violated or exceeded, the taxpayer shall purchase all appropriate business licenses from the municipality for the entire license year and without regard to this section.
- (b) Mere delivery of the taxpayer's merchandise by common carrier shall not allow the municipality to assess a business license tax against the taxpayer, but the gross receipts derived from any sale and delivery accomplished by means of a common carrier shall be counted against the seventy-five thousand (\$75,000) limitation described in the preceding section if the taxpayer also during the same license year sells and delivers into the taxing jurisdiction using a delivery vehicle other than a common carrier.
- (c) A common carrier, contract carrier, or similar delivery service making deliveries on behalf of others shall not be entitled to purchase a delivery license.
- (d) The delivery license shall be calculated in arrears, based on the related gross receipts during the preceding license year.
- (e) The purchase of a delivery license shall not, in and of itself, establish nexus between the taxpayer and the municipality for purposes of the taxes levied by or under the

authority of Title 40 of the Code of Alabama or other provisions of law, nor does the purchase of a delivery license conclusively determine that nexus does not exist between the taxpayer and the municipality.
